10. 中欧法学院参加"新欧洲对当代中国的研究——法律专家组会议"


CESL's Participation in the New European Research on Contemporary China Conference: Legal Panel

The book "Concise Chinese Tort Laws", written by Professor Li Xiang and Jin Jigang, is the first book in the new China-EU Law Series. It provides international readers with a fresh perspective on China's tort law system by exploring real cases in order to explain the courts' application of China's tort laws. Professor Li Xiang is a nationally recognized expert in the area of comparative tort law. He joined the Law faculty of China University of Political Science as an associate professor in 2006. He recently received a letter from President Obama acknowledging his excellent contributions and achievements. Co-author Jin Jigang is a litigation attorney with the international law firm Skadden, Arps, Slate, Meagher&Flom LLP in United States. He specializes in IP and complex commercial litigations and operates out of the firm's Silicon Valley office.

This book will also be published in Chinese by Tsinghua University Press.
